- 1. Apologies for absence were received from JF
- 2. Members' declarations of interests & requests for dispensations none
- 3. Reports from the County and/or District Councillor

A report from JF had been circulated and was noted.

4. To consider any matters relating to highways, pavements, footpaths and trees not already considered, including village signs and dog fouling.

The following matters were discussed:

 Village Signs: JF & GM had each committed £3000 towards repairs to/replacement of directional road signs in the village. This should cover the cost of six signs. The Council noted that it had very limited reserves and so could not commit any of its funds at this stage. JH would liaise with Suffolk

- Highways regarding next steps and also Highways' responsibility for mandatory signage e.g. 30-mile signs
- Highways had advised that works to renew the road markings in Bells Lane had now been ordered and are due to be completed by 28/11/24.
- Traffic to and from Gressingham Factory: PR to liaise with factory on the issue and report back.
- Vehicle Activated Speed Signs: It was noted that from time to time a
   Highways VAS was put on the pole on the way out of the village to Rickinghall.
   It was felt that what was needed were poles at the four points into the village.
   The Clerk would investigate options for this and also for the purchase of a
   VAS by the Parish Council.
- Dog fouling: The Bridleway was a particular issue. Clerk to produce laminated notices

# 5. Public participation session

The idea of Quiet Lanes was raised. When the idea had been previously raised, JF questioned the practicality.

# 7. Planning

AG reported that he had done some cutting back in Cowfen Lane (Path). The issue had also been reported by the Clerk to Highways and the Rights of Way Officer had instructed a contractor.
